I, *Benjamin Croff* born in *Lancaster Co* in the State of *Pennsylvania* aged *Twenty one* years, and by occupation a *Printer* Do HEREBY ACKNOWLEDGE to have volunteered this *Twenty fifth* day of *February* 1864, to serve as a **Soldier** in the **Army of the United States of America**, for the period of **THREE YEARS**, unless sooner discharged by proper authority: Do also agree to accept such bounty, pay, rations, and clothing, as are, or may be, established by law for volunteers. And I, *Benjamin Croff* do solemnly swear, that I will bear true faith and allegiance to the **United States of America**, and that I will serve them honestly and faithfully against all their enemies or opposers whomsoever; and that I will observe and obey the orders of the President of the United States, and the orders of the officers appointed over me, according to the Rules and Articles of War.

Mustered into the service of the United States, for three years or during the war, from date of enlistment, in Company *A* *119th* Regiment of *Pennsylvania* Volunteers, on the *25* day of *February*, 1864, at *Philadelphia*
